## SPONSORSHIP AGREEMENT

Child Sponsorship Agreement (the “Agreement”) is entered into by Esteemed Children Trust (the “Organisation”), a non-profit organization registered in Zimbabwe under the Companies and Associations Trustees Act (Chapter 24:04), having its premises located in Kensington, Harare, and the undersigned sponsor (the “Sponsor”).

### Recitals

**WHEREAS**, the Organisation and the Sponsor, desire to work together in child sponsorship, whose purpose is dedicated to alleviate poverty from orphan and vulnerable by ensuring quality education and social empowerment to the less privileged children in Zimbabwe.

**WHEREAS**, the foregoing organisational programs are determined to give a leverage to the underprivileged children in Zimbabwe, by eliminating poverty through child empowerment programs, varying from education empowerment, psycho-social support, health and nutrition.

**WHEREAS**, the Sponsor, desires to work with the Organisation in sponsoring less privileged children in areas of education and social empowerment, subject to the privileges, rights, duties and obligations set forth herein.

**NOW, THEREFORE**, the Organisation and the Sponsor do hereby agree as follows:

### 1.0 Parties to the Agreement.

### **4.0 Agreement Cancellation**

4.2 Subject to clause 3.1 above, the notice period shall be a minimum of sixty days (two months) upon the cancellation date.

### **5.0 Terms of the Agreement.**

5.1 The Organisation and the Sponsor agree to meet their obligations as stated below in this Agreement.

5.2 The Organisation and the Sponsor are bound to fulfil the obligations of this Agreement.

### **6.0 The Obligations of the Agreement.**

6.1 The Organisation agrees to:

6.1.1 Offer facilitation and administration towards the sponsorship programs.

6.1.2 Issue monthly report to the Sponsor pertaining to feedback on child's wellbeing with photos, expense receipts / statements, funding balance for the month and school progress reports.

6.1.3 Issue suggestions, recommendations and requests, including notification of date the report will be supplied to sponsor.

6.2 The Sponsor agrees to:

6.2.1 Disburse sponsorship funds established in the sponsorship budget.

6.2.2 Disburse the funds through World Remit / MoneyGram to the Organisation, first week of each month / last week of previous month for the following month.

6.2.3 Channel all requests to the child/family (and vice versa) through the Organisation or next of kin.

6.2.4 Maintain regular monthly contact with the child through the Organisation or next of kin.

6.2.5 Provide mentorship to the sponsored child subject to details on Sponsor Registration form.

6.2.6 Disclose all relevant mentoring details to the Organisation, subject to clause 6.2.5 above.
